Water part which is highly nutritional is being used as sprinklers on plants to prevent from diseases and the solid compost then later added with an innovative Elworld formula to be used as natural pesticide on the crops. Not just on the fields but off-farm also, Mr. Dwivedi and his team promulgate clean and healthy living. Company has established a solar-run organic food canteen at corporate office in Noida (UP), which caters organic meals to each employee at the group.


